### 1890 **Cycling Club**

The annual general meeting of this club was held on Tuesday evening in the club room under the presidency of the Rev W I Blaker. There was a good attendance of members. The officers for the ensuing year were elected as follows: President, Rev W I Blaker; Captain, Mr G Lush; sub-captain, Mr A Bull; treasurer secretary, Mr J Shute; committee, Messrs W W Kendall (chairman), H Abbott and G Tancock. It was decided to alter the name of the club to The Tisbury Cycling and Athletic Club. The club's financial condition is very satisfactory.

### **A Worthless Character**

At a special petty sessions at Tisbury on Wednesday, before Lord Arundell of Wardour and Colonel Best. George Ings, of Tisbury, labourer, was brought up in custody charged with stealing three pecks of potatoes, value 1s, the property of Thomas Wilkins, baker, of Tisbury. Also with stealing a bladder of lard and three pounds of moist sugar, value 1s 5d, owned by Wyndham Green, dairyman, of Chicksgrave. The prosecutor in the first charge said he rented a piece of allotment land at West Tisbury, and in the land was a potato pit.

On the 16<sup>th</sup> inst, he found that the pit had been interfered with and some potatoes removed. He had since examined some potatoes shown him by the police, and identified them as being of a similar variety to those he had lost. Superintendent Bull said he apprehended prisoner on another charge on the 17<sup>th</sup>, but before removing him from his house, told him that he was suspected of stealing a quantity of potatoes. Witness searched the house and found the potatoes now produced. Upon the second charge, William Lone, assistant at Messrs Laversuch's shop, said he served prosecutor with lard and sugar on the 17<sup>th</sup> January. He now produced samples.

Prosecutor said on placing his purchases at Messrs Laversuch's in his cart, he observed prisoner standing near. He drove to the Bennett Arms Hotel and left his cart in the yard. On going to his cart upon leaving the hotel, he missed the lard and sugar. Before placing the sugar in his conveyance, he marked the bag, which he now identified.

Supt Bull stated on going to prisoner's house at Tucking Mill, West Tisbury, and charging him with the theft, he denied all knowledge of the articles. On the table in the room in which witness charged the prisoner was the bag of sugar produced, and a jar containing sugar of a similar kind. On taking prisoner by the shoulder and shaking him, the lard fell from beneath his clothing.

Prisoner pleaded guilty on both charges. Supt Bull proved a number of previous convictions and said prisoner was a worthless character and a brute to his wife and children. Three months' hard labour.

Psalm xxxix was very nicely changed by the choir. At the conclusion of the lesson, hymn 400 A & M was sung and at the completion of the service at the grave, hymn 140 was sung. Bro W Hill (secretary to the Lodge) read the address of the Order. The arrangements were ably carried out by Mr Herbert Osmond. Deceased was in his 27<sup>th</sup> year.

**Vital Statistics**

During the quarter ending June 30<sup>th</sup>, Mr H Osmond has registered in the Tisbury District, 14 deaths, (8 males and 6 females). The deaths included eight over 60, four between 1 year and 60, and two under 1 year. The births registered during the same period numbered 12 (7 boys and 5 girls). The deaths in the corresponding period of last year were 8 in number and the births 27.

**Tisbury Petty Sessions**

Henry Mullings, labourer, of West Tisbury, was summoned by the Guardians of the Tisbury Union to show cause why he should not contribute towards the maintenance of his wife, who is now an inmate of the Devizes Asylum.

Mr James Isaacs, relieving officer of the Tisbury Union, stated that defendant's wife had been chargeable to the Union for three months, the union having to pay 8s 9d per week for her maintenance. Application had been made to the defendant to pay 2s per week, but he had refused to pay anything.

Evidence was given by Mr John George Wood, in whose employ defendant has been, that for the past eleven weeks he had earned on an average 12s 3d per week. Defendant said he was now receiving 10s per week, out of which he paid 4s weekly for the keep of his infant child. The Bench made an order for the payment of 2s weekly.

**Sick Nurse Fund**

Some months since, a movement was initiated in the town with the object of providing a fund wherewith to establish in the town a sick nurse, whose services would be at the disposal of the inhabitants.

The proposal was from the first received with the favour which it so richly merited, but it could not be expected that the sum necessary should be forthcoming without some little effort, as Miss Randall, the hon. secretary, and the committee of ladies who undertook the carrying out of the idea found.

On Tuesday afternoon there was held in the Victoria Hall an "American" fair or rummage sale in aid of the fund, and the success attending it was most gratifying. No less than 670 persons paid for admission and the sum raised was £36 15s. Articles for the sale were most readily given by the inhabitants. Among the ladies and gentlemen visiting the sale during the afternoon were Mrs Morrison, Miss Morrison, Miss Dorothy Morrison, Misses Halliday, Rev F E Hutchinson, Rev W H Lewis, Rev W J Blaker, Rev R Selwyn and Mr J H Bracher.

#### **Theft from the Vicarage**

At the Wilts Quarter Sessions, on Tuesday, Elizabeth Saunders, a domestic servant, was charged with stealing, and Mrs Becker, sister of Saunders, and a lodging house keeper, of Ilfracombe, was charged with receiving, knowing them to be stolen, a quantity of carpets, bed and table linen, and other articles, of the value of £5, the property of the Rev F E Hutchinson, in whose service Saunders had recently been.

Mr Ravenhill, instructed by Mr J Trevor-Davies of Sherborne and Yeovil, prosecuted, and Mr Radcliff, instructed by Mr Gratton Barnett of Ilfracombe, defended.

The circumstances in connection with the robbery have already been reported in these columns. The jury found Saunders guilty and she was sentenced to a months' hard labour but Becker was acquitted. Mr Radcliffe applied that the prisoner should be dealt with under the Probation of Offenders Act, but the Chairman, the Marquis of Bath, did not consider it within the meaning of the section, which applied to persons of extreme youth.

#### **Tisbury Petty Sessions**

Thos Snook, a newsagent, of Tisbury, was on Thursday, Aug 4<sup>th</sup>, charged on a warrant, before Lord Arundell, with threatening to shoot his mother with a revolver. Evidence in support of the charge was given by Mrs Snook and a boy named Frank Sanger, and prisoner, who pleaded in excuse for his unnatural conduct that he was in drink at the time, was ordered to find two sureties of £5 each and himself in £10 to be of good behaviour for three months. Failing to find the sureties prisoner was sentenced to a month's imprisonment with hard labour.

In consequence of defendant's violence, his wife left him, and went to live with the complainant, who is her daughter.

On Friday he went to complainant's house, created a disturbance and threatened to "do for her". She was afraid he would carry out his threat, and now asked that he be bound over to keep the peace. In his defence, Allen imputed charges against his wife, who is sixty five years of age, as the reason she would not live with him. The Bench bound defendant over in £5, and one surety in £5, to keep the peace for three months.

**Tisbury Special Sessions**

At the special sessions on Tuesday, before Mr W E Moss-King and Mr F Dunston, Harry Baker, a labourer, of West Tisbury, was charged with being drunk and disorderly, and further with resisting the police in the execution of their duty.

PC Millard said that on Saturday night, the 25<sup>th</sup> inst. at about 10.45pm, he was in Tisbury High-street, where he saw prisoner ejected from the Benett Arms Hotel. He was drunk and very disorderly, and refused to go home quietly, although repeatedly requested to do so.

Witness then proceeded to take prisoner into custody. Prisoner tripped him up, and they both fell to the ground. Whilst on the ground prisoner kicked at him several times. He called Mr Bull and PC Newman to his assistance, and, with their help, got Baker to the Police station, the prisoner violently resisting the whole of the way.

Arthur Bull, outfitter, corroborated. Frank Oxenham Ford, landlord of the Benett Arms Hotel, said prisoner went into his tap room at about 20 minutes to 11pm. He was intoxicated, and witness refused to supply him, and requested him to leave, which he refused to do. Witness, with the assistance of a customer, ejected him.

Prisoner who pleaded guilty, had been several times previously convicted, and was sentenced to one month's hard labour.

#### **1896 Strange but True**

There is a town (?) in the United States of America bearing the name of Chilmark, close to another town named North Tisbury. This fact in itself is of interest to Wiltshire people. It is somewhat singular that out of a population of 146 persons, 36 men, women and children are deaf and dumb, and were born so; that is to say, that one in every four are speechless. In five families of Chilmark (United States), out of 28 children, 15 are deaf and dumb. This taint of heredity has descended for 250 years. It is most amusing to live in this town, where most of the people talk in pantomime. Happily, the village of Chilmark, in Wiltshire, does not follow its American namesake in this respect, for out of 150 children, not one is deaf or dumb.

#### **1896 County Court Shaftesbury**

The only case of interest to come before His Honour Judge Philbrick on Monday was one in which George H B Lever, of Chicksgrove Farm, Tisbury, sued James Henry Bracher, of Place Farm, in the same parish, for £5, for 16 days' keep of 205 sheep. Mr Trethowan, of Salisbury, represented the plaintiff and Mr W Marsh, of Yeovil, the defendant.

The plaintiff's case was that in June of last year the defendant wanted some keep for his sheep, and plaintiff, having four and a half acres of vetches, in good condition, he was desirous of letting them. He spoke to the defendant on the subject, and he said he must first see his shepherd, Fred Penny. Subsequently Mathias Burton (defendant's bailiff) called upon plaintiff in reference to the keep, and witness told him his charge for the keep would be £5.

Burton replied that of course he (plaintiff) could not afford to pay the rent and buy seed for nothing. Burton said he would again go and see his master. On June 8, the sheep came to plaintiff's farm, and were folded in the vetches. They remained there 16 days, and every day they were taken by defendant's shepherd to West Wood Down (in Mr Bracher's occupation) for water. The shepherd remarked that the sheep had done well when he took them away altogether.

On a portion of defendant's farm at the time there was no feed, owing to the dry season. Witness sent in his account of £5 to the defendant, and the latter repudiated any agreement to pay anything. Cross examined: His vetches were not a failure. Bracher did not tell him he would not pay a farthing for the keep of the sheep, as the keep was so poor.

Emma Lever, wife of the plaintiff, gave corroborative evidence, and William Knight, shepherd to the plaintiff, said the feed was very good, but admitted it was a mixture.

In defence, Mr Bracher swore there was no agreement on his part to pay anything for the use of the keep. He saw the keep in question and it was very poor stuff, consisting of vetches, oats, bruckled corn and couch. He told plaintiff, if it would be any convenience to him, he would consent to allow his sheep to be folded off there by night, they returning to his Down to feed by day. He only consented to their going there, however, on the condition that plaintiff found the hurdles for their folding.

Plaintiff said he did not want any remuneration, and would be satisfied with the manorial return to the ground, as he wished to plough it in. He distinctly told plaintiff he should pay nothing for the keep, as it was so poor, and plaintiff agreed to accept the sheep on these terms, and said he would provide hurdles.

Subsequently defendant received a letter from plaintiff to the effect that, as the weather was so very bright, he dared say he (defendant) meant to give him a little for the vetches, as they were better than he thought they were. (This letter was handed to His Honour). Witness gave his bailiff, Mathias Burton, no instructions to agree with defendant on any price. At the time defendant had an abundance of keep and merely sent his sheep to accommodate the plaintiff.

Frederick Penny, plaintiff's head shepherd, said the feed in question would not have lasted the sheep more than four days had they not been taken to the Downs every day. Mathias Burton gave evidence disputing plaintiff's version of the conversation between them. His Honour summed up, and said in the face of plaintiff's own letter, he must give judgement against him, with the usual costs.

#### **Non Attendance at School**

Sidney Parham, Richard Humphries and Henry Wadham, all labourers, of Tisbury, were summoned at the instance of Mr G H Ingram, officers to the School Attendance Committee of the Tisbury Union, for having failed to send their children regularly to school.

Parham and Wadham were represented by their wives, who urged that illness was the cause of the irregularity. In the absence of medical certificates, however, the Bench imposed a fine of 1s in each case. There were two summonses against Parham, who there had to pay 2s. Humphries did not appear and a fine of 5s was inflicted. There was only one summons against him.

Frank Beal, a labourer, of Cherryfields, Tisbury, was fined 1s, on the evidence of Mr S J Isaac, officer to the School Attendance Committee of the Tisbury Union, for having failed to send his son John, aged 10, regularly to school.

Richard Humphries, of Tisbury, similarly summoned by the Union Committee, was fined 5s, after having been previously convicted.

### **Judgement by Consent**

Mr Trevor-Davies, who appeared for the plaintiff in the case of Thick v Snook, heard at Wimborne County Court on Saturday last, stated that defendant (for whom Mr Raymond appeared) had consented to judgement being entered against him for £7 and costs, payable by instalments of £2 per month.

This was an action brought by Mrs Julia Thick, of Wickwood, Tisbury, against H C Snook, cycle maker, trading as Snook & Sons, New Borough, Wimborne, for £10, amount paid to defendant in part payment of premium under an agreement to apprentice Austin Edward Thick, and which money was to be returned in the event of the boy not being satisfied with the proposed apprenticeship within one month. Judgement was entered for the plaintiff on the terms mentioned.

### **1897 Neighbours' Quarrel**

James Gray, a gardener, of East Tisbury, was summoned by Annie Lambert, a single woman, of West Tisbury, for assaulting her on the 24<sup>th</sup> February, and there was a cross summons in which Gray charged the woman with assaulting him at the same time and place.

Annie Lambert stated that on the date named, shortly after mid-day, the defendant came to her father's house and said he wanted to see her. She opened the door, and he thereupon placed his foot inside for the purpose of keeping it open. She, with her sister, endeavoured to shut the door, but the defendant got her away by scratching her hands, and, going inside, slapped her on the side of the head, and also struck her in the mouth, which he caused to bleed. At the same time, with an oath, he said "Take that" and walked away.

Defendant's mother resided next door to the witness, but she had never previously spoken to him, and did not know of any reason why he should assault her. Witness had had some words with the man's mother.

By defendant: She put her hand on his shoulders to push him from the door, but used no disgusting language.

Lily Lambert, sister of the last witness, gave corroborative testimony, and Edward Lambert, a carter, farther of the young woman, also gave evidence to the effect that Gray admitted the assault to him. In defence, Gray denied any assault, urged that the woman struck and abused him, and explained that the quarrel was due to the fact that Annie Lambert had abused his mother. In the result, the Bench fined the man 10s and costs and dismissed the summons against the woman.

The judge amended the order to 10s in the £ at the rate of 5s per month.

Frederick .... (unreadable), shepherd, of Tisbury, made a like application. With debts amounting to £23 1s 5d, applicant offered a composition of 5s in the £, at 5s per month. Mr Rutter opposed the application on behalf of the proprietors of the Tisbury Stores. His Honour increased the order to 10s in the £.

### **County Court Salisbury**

Fray v Frank & Sarah Lambert.

All the parties from Tisbury. Mr Rutter for the plaintiff and Mr Nodder, of Salisbury, for the defendants. Plaintiff claimed £21 7s 11d for goods supplied and money lent. A discussion took place between the Judge and Mr Rutter as to whether both husband and wife could be sued. His Honour thought both could not be, whilst Mr Rutter argued to the contrary. The husband, it was stated, admitted the debt and offered £1 per month. The wife disputed the debt and the liability. The matter was settled by His Honour giving judgement against the husband for the full amount.

"Lieutenant Colonel Sir Fleetwood Edwards is commanded to acknowledge the receipt of the Rev F E Hutchinson's letter of the 10<sup>th</sup> inst., and in reply to inform him that the Queen wishes Mr William Parham to receive £5, and Sir Fleetwood Edwards would be very much obliged to Mr Hutchinson if he would have the enclosed £5 note delivered to him as a donation from Her Majesty. Dated July 15, 1897"

It is gratifying to learn that the injured man is progressing very favourably although it will be some time before he will be able to resume his regular employment.

#### **A Son's Responsibility**

Thomas Fay, of West Tisbury, was summoned by the Tisbury Board of Guardians to show cause why he should not contribute towards the support of his father, Thomas Fay, who was at present receiving outdoor relief. Mr Marsh, of Yeovil, who appeared for the Guardians, said the defendant's father became a pauper in the present year, and he had since been receiving 1s 6d a week from the Guardians.

The defendant, who was employed on the railway, earned 17s a week, and had two children. The guardians would be content if an order was made for the defendant to contribute 1s a week towards the support of his father. The Bench made an order for the defendant to contribute 9d per week.

He died in hospital from enteric fever.

The official receiver will administer the estate under a summary order.

#### **Forthcoming Military Manoeuvres**

It is reported that it has been decided by the War Office authorities to make Tisbury the centre for the Western Camp in the forthcoming manoeuvres, in which 50,000 troops will be engaged.

Camps, it is stated, will be formed on Lady Down, at Cricklade, Swallowcliffe, and, in fact, all round the district, of which Tisbury will be the central depot for supply requisites in the shape of food and other requisites for the manoeuvres, which, it is stated, will continue for a somewhat lengthy period.

It is estimated that around this neighbourhood there will be no less than 20,000 or 25,000 troops encamped, the manoeuvres being the largest ever carried out. Officials are now engaged from the War Office making arrangements in the neighbourhood. Mead Furlong and Wallmead, occupied respectively by Mr J H Bracher and Mr James Street, will, it is stated, be two depots for food, &c.

At this stage of the proceedings, defendant pleaded guilty and the Bench decided that further evidence was unnecessary. In the result, the magistrates dealt with the lad under the First Offenders Act, on his father undertaking to flog him the presence of a constable.

### **Theft from the Benett Arms Hotel 1899**

**Tisbury Petty Sessions.** On Tuesday, John Gurd, a young man living at Tisbury, was brought up in custody before Mr J E Jeffery, charged with stealing six cigars and three 1d packets of cigarettes from Mrs Griffin, Benett Arms Hotel, on the previous Sunday. Formal evidence was given and accused was liberated on bail.

At a special Court on Monday, before Colonel Best (in the chair) and Mr J E Jeffery, John Gurd, lately ostler at the Benett Arms Hotel, Tisbury, surrendered to this bail to answer a charge of having stolen six cigars and three packets of cigarettes, the property of Elizabeth Griffin, the proprietress of the Benett Arms Hotel.

Mrs Griffin, the prosecutrix, said prior to the date of the present charge she had missed cigars, as well as a quantity of cigarettes and tobacco. She recognised the cigars and cigarettes produce d as being the same brand as she sold. She valued them at 1s 3d. Percy Griffin, son of the last witness, spoke to having found in the stable these cigars and a quantity of cigarettes, which he gave to his father. Supt Fox arrested prisoner, who replied, "Yes, sir, I took them" (meaning the cigars and cigarettes), and went into the bar and pointed out the box he took them from. Defendant was fined £1; in default, one month. The fine was paid.

At the Romsey Borough Police-court on Saturday last Frank Scott, a labourer of Tisbury, was charged, before Alderrman Tuck, with placing himself in a position to beg. Prisoner, who had a wife and child with him, was singing and soliciting alms. Prisoner said he did not know he was doing any harm, but was sorry if he had. A letter from the Vicar of Tisbury spoke of the man and his wife as respectable people and on promising to return to his own parish, the charge was dismissed.

### **Serious Stabbing Charge**

At Tisbury Petty Sessions on Monday, Frank Lever, of Tisbury, was brought before Colonel Best, charged with stabbing William Baker, of High-street, Tisbury, on the previous Saturday night. He was remanded until Monday.

### **Tisbury Police Court**

On Monday, Frank Lever was, on remand, before Colonel Best and Mr F Dunston, charged with stabbing William Baker, butcher and farmer, of Tisbury, on September 16<sup>th</sup>.

Prosecutor related the circumstances, which commenced with his finding prisoner in a shed occupied by him about half past ten on the night named. He asked prisoner what right he had there, and he replied that he had seen a man with a sack over his shoulder go into the gate of the field, and he was watching him to see what he was at. Prosecutor told him that he did not believe him, and walked on towards home. Prisoner followed behind him, and swore at him. He also attacked him (prosecutor), and a scuffle ensued, when they both fell down on a stone heap beside the road and prisoner said to him, "When I get up I will do for you".

Prosecutor again walked on towards home, when prisoner went up behind him and stabbed him in the left shoulder. Prosecutor met a man named Frederick James Mould, and subsequently saw PS Haddrell. The latter, in the absence of Dr Ensor, bound up his wound, which Dr Ensor said was about an inch long; it was deep and the blow inflicting it must have been given with considerable force from behind.

When arrested by Sergt Haddrell, prisoner said "What did the old fool hit me in the head for? I will hit it into him again when I come out, if I get five years for it. I don't care if I kill him". Supt Fox said that at his office, prisoner picked up the knife produced and said "That's the one I done it with". The accused asked no questions, and made no statement. He was committed for trial at the next Quarter Sessions.

### **Wilts Assizes Devizes**

Frank Lever, 41, labourer, was indicted for unlawfully stabbing and wounding William Baker with intent to do him some grievous bodily harm at East Tisbury on the 16<sup>th</sup> September. Mr C A S Garland was for the prosecution.

Prisoner pleaded guilty to unlawfully wounding, but not to the intent to do grievous bodily harm. This plea was accepted, the Judge remarking that there was very little difference. Prisoner had been several times previously convicted for violence and the last time was for stabbing. He would now be sent for two years' imprisonment with hard labour.

In its career up High-street and collided with a bicycle standing by the side of the road, considerably damaging the machine. The animal was pluckily stopped by W Edwards near the Benett Arms Hotel. The front of the carriage was badly smashed and horse received a few cuts.

**Wilful Damage**

Uriah True, a labourer of East Tisbury, was summoned at the instance of Alexander Godwin, of East Tisbury, manager to Mr Alfred Lush, for maliciously damaging a padlock attached to a field gate, to the amount of 1s, the property of Mr Lush. From the evidence of two lads named Stephen Hibberd and Herbert Martin, it appeared that the defendant unhung the gate from its hinges and threw it down, damaging the padlock which was attached to it to the amount of the above mentioned. Fined 2s 6d, and ordered to pay the amount of damage, the costs being remitted. Supt Fox stated that he received several complaints of similar conduct on the part of youths of Tisbury and the chairman said future offenders would be more severely with.
