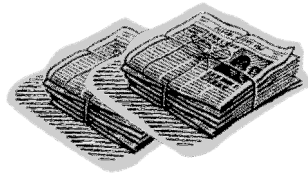

1830-1859

1830 Sheep Attacked

On Monday night, some dogs entered the fold of Mr John Ricketts, of East Knoyle, and dreadfully mangled 33 of the sheep

1833 Salisbury

Forty-two able-bodied men (emigrants to Upper Canada), thirty-three from East Knoyle and nine from Hindon, passed through this city on Saturday last. They will embark from Portsmouth. They appeared to be comfortably provided for their long journey.

1834 East Knoyle, appellants, Fisherton de la Mere, respondents

(At Wilts Quarter Sessions) This was an appeal against an order for the removal of Joseph Marchant, his wife and two children, from Fisherton to East Knoyle. It was admitted that the pauper's birth settlement was in East Knoyle; but contended that he had gained a subsequent settlement; to prove which, the pauper himself was called, who, in the course of his evidence, deposed that at the age of 16 or 17 years, he went to the Rev Mr Phillip's at Codford, and asked the groom if Mr Phillips was in want of a servant?

That the groom enquired, and afterwards told the pauper that Mr Phillips would give him 8s a week as under groom: that he (pauper) was desirous of obtaining 10s a week, but that the groom, after again consulting with Mr Phillips, told him that Mr P would not give him more than 8s a week, winter or summer, all the year round; that at the suggestion of the groom, he went a month upon trial, and afterwards continued in Mr Phillip's service for several years.

Mr Bingham, for the respondents, called the groom who corroborated the pauper's statement, except as to the words "all the year round", which he said were never used. Upon these words, however, the case depended; as an agreement, at so much per week "for winter and summer" would not constitute a yearly hiring. The Court, seeing no reason to doubt the pauper's statement, (it having been very fairly and frankly given) quashed the order.

Parochial Meeting of Landowners and Tithe Owners

We, the undersigned, being landowners within the parish of East Knoyle, in the county of Wilts, whose interest is not less than one fourth part of the whole value of the lands subject to tithes in the said parish, do, by this notice, in writing under our hands, call a parochial meeting of landowners and tithe owners within the limits of the said parish, for the purpose of making an agreement for the general commutation of tithes within the limits of the said parish, pursuant to the provisions of an Act passed in the sixth and seventh years of the reign of his late Majesty, King William the Fourth, intituled "An Act for the Commutation of Tithes in England and Wales".

And we do hereby also give notice that such meeting will be held at the church, in the said parish, on Wednesday, the twenty seventh day of September next, at the hour of twelve in the forenoon. Given under our hands, this first day of September, 1837

About a fortnight since, an old gentleman, named Charles Ford, 82 years of age and of weak intellect, left his home at East Knoyle, Wilts, and to the great alarm of his friends and relations, has not since returned.

He has been heard of at Mere, Frome and Radstock, and at which latter place he was seen on 11th inst., but no further tidings have yet been learned respecting him.

He had on a black hat, black lapelled coat, dark trousers and leathern gaiters over. He is about six feet in height, but rather stoops. He has grey hair and is very deaf. A placard has been issued stating that information respecting him will be thankfully received by Mr J Snook of East Knoyle.

Charles Ford, the old man whose sudden disappearance from East Knoyle we lately noticed, was found in an exhausted state, lying against a barley-mow, on the premises of Mr Parsons of South Cadbury, near Wincanton, where he had evidently lain throughout the whole of the previous inclement night. He was immediately conveyed to the New Inn and every method which skill and benevolence could suggest, was tried to rally him, but in vain; as he expired about eleven o'clock the same evening, without being able to tell his tale of woe, or indeed to speak a word so completely was nature exhausted.

East Knoyle church is closed for the purpose of undergoing extensive alterations and enlargement under the direction of T H Wyatt Esq., the Diocesan architect. Mr Hale of Warminster has undertaken the contract for the repairs. It may not be generally known that this parish is the birth-place of Sir Christopher Wren, who was baptised there by his father who was rector of the parish in the reign of Charles the First.

- 1848 Licence Granted**
Mr George Pittman and Miss Elizabeth Jukes were married in Hindon Episcopal Chapel on Thursday last, May 25, being the first couple united since the licence recently granted by the Lord Bishop of Salisbury for the solemnisation of marriages in the above mentioned place of worship. The day was bright and auspicious, and the inhabitants of Hindon appeared to welcome with much interest the restoration of their ancient privilege, which, in consequence of the connexion of Hindon with East Knoyle - a connexion now dissolved on the appointment of a new incumbent to that living - had been withdrawn since the year 1776.

George Maidment, of East Knoyle, charged with stealing in the dwelling house of John Moger, a quantity of bread and cheese and other articles; also charged with stealing a knife, the property of Thomas Mead; also charged with stealing a bag, the property of Henry Mells.

- 1850 Committed to County Gaol (Salisbury)**
James Fletcher and Stephen Beale, both of East Knoyle, charged with having feloniously assaulted and stolen from Peter Fletcher a silver watch, one coat and one waistcoat, his property, at East Knoyle.

- Hindon Petty Sessions**
James Fletcher and Stephen Beale were also in custody charged with having, at 10 o'clock on the night of 4th inst., at East Knoyle, assaulted and beat Peter Fletcher, a poor man, stealing from him a watch, half a sovereign, 3s in coins, a coat and a waistcoat. The court after going through the evidence, committed both to take their trial at the next assizes.

- 1857**
On Tuesday night last, the Rectory was feloniously entered during the absence of the Rev C Morgell and the larger part of his family from home. The burglars effected their purpose through the window of a room on the ground floor having first removed, by means of a knife, a portion of the pane of glass opposite the bolt. It so happened that neither the shutters were closed, nor the fastenings with the spring-bell fixed, as usual; otherwise it is believed the attempt would probably have failed, in that quarter at least.
- As it was, the noise was distinctly heard the by coachman, whose sleeping room was directly over that into which the thieves made their way; but the servant, imagining the sound to proceed from the rubbing of the branch of a shrub against the window, disregarded what he heard and went to sleep, consequently no alarm was given. Next morning the back door was found open and marks of footsteps were traced throughout almost the whole of the lower part of the dwelling. The pantry was carefully searched by the thieves and the plated articles left there tried and rejected by them; some boxes, thought doubtless to contain money, were burst open, one cupboard was forced and the larder plundered.
- It would appear the burglars leisurely regaled themselves in the kitchen, but we are happy to state nothing of any value fell into their hands and providentially those members of the family who were at home remained in ignorance of what was occurring.
