

Stolen or Strayed

From the pasture of Knoyle Summerlease, in the county of Wilts, on the 22d or 23d of September, three oxen, of the Devonshire breed, two of them sparked red and white, the other red; they are between seven and eight years old, and having been lately worked are marked on the neck with the yokes. Stolen Oxen

On Tuesday, William Marsh and Matthew Bacon were examined by the sitting Magistrates at Union Hall in the borough of Southwark, on a charge of having stolen three oxen, which the officers secured at Lambeth at five o'clock on Monday morning as they were going to drive the beasts to Smithfield. They were driven from Wiltshire, out of a field in East Knoyle, and were the property of Thomas Grove, Esq. The prisoners were committed for re-examination, with a view to know whether other charges existed against them.

1805 Left their Families

Whereas two men of this parish, both named John Maidment, have run away from and left their families chargeable. Notice is hereby given that whoever will bring both or either of them to the Churchwardens or Overseers, shall receive a reward of Forty Shillings for each. The one is about 40 years of age, 5 feet 4 inches high, of a dark complexion and wears a blue coat, white flannel waistcoat and leather breeches. The other is about 38 years of age, 5 feet 5 inches high, small features and has a hesitation in his speech, wears a round frock and flannel waistcoat.

1807 Nisi Prius

There were eight causes at Nisi Prius, one of which was an action for ejectment, brought by Mr Cooth of Blandford, against the Rev. Dr. Jackson of Donhead, to recover legal possession of an estate at East Knoyle which has been the subject of litigation between the parties for some years past in the Court of Chancery. The plaintiff proved his title under the ultimate limitation in a settlement made on the marriage of Richard Jackson, D.D. the late uncle of the defendant, with a relation of the plaintiff, and also his interest in a satisfied term of years granted by the husband and wife during their coverture; whereupon a verdict was recorded for the lessor of the plaintiff, subject to the opinion of the Court of King's Bench, upon three exceptions to the evidence by the defendant's counsel.

1808 Bigamy

Last week a man by the name of Maidmant was brought before the County Magistrates on a charge of bigamy. It appears that he ran away, about four years ago, from the parish of Knoyle in the county of Wilts, leaving his wife and six children chargeable to that parish. Ever since that time he has been living at Twyford, near this city (Winchester), and pretending to be a single man, he married a young woman of that village. He was fully committed for trial.

Hampshire Chronicle Monday 07 November 1808

1809 Storm

A tremendous storm came on here on Thursday evening, the lightning was extremely vivid, the peals of thunder loud and awful and the rain descended in torrents. About nine o'clock, a flash of lightning illuminated the whole horizon and was followed by a crash of thunder more loud and awful than any by which it had been preceded.

The Mercury stage coach from London to Exeter was then near Woodyat's Inn; a sailor on the roof was struck dead by the lightning and at the same instant, one of the horses was killed by it. A woman who sat on the roof by the side of the sailor declares that the stroke was visible, that she saw the lightning on his face and in the eagerness of her first sensations, endeavoured to brush it off with her hand. The woman was unhurt as were the other passengers and coachman. We have not yet heard of any other fatal accident by the lightning. The windows in the greenhouse &c. of the Rev Mr Ogle at Knoyle, were broken to pieces by the hail.

- 1819 Return of John Benett**
On Friday the 24th ult. the return of John Benett, Esq., as a representative of this county, was celebrated by the gentlemen, farmers, and inhabitants of East Knoyle. The morning was ushered in with the ringing of bells, and the four pinnacles of the church were decorated with appropriate banners and laurels. At twelve o'clock, every poor person in the parish walked in procession that that beautiful spot Knoyle Hill, where men, women and children were all regaled with bread, cheese and strong beer. A marquee was provided for the accommodation of ladies. Triumphal arches were also erected, decorated with laurels, ribbons, &c. and an excellent band of music attended.

About three o'clock, Mrs Benett arrived on the hill, and with her appearance filled every heart with welcome emotion, which was testified by reiterated acclamations. Mr and Mrs Benett's health was drunk with three times three, and the glorious majority of 166, as was also "The Northern Lights, and May the powerful Rays of the South be always ready to protect the Independence of the County of Wilts" &c. The fineness of the day added to the beauty of the scene. The merry dance was kept up to a late hour, and the amusements of the day concluded with a blazing bonfire.

On the 24th ult, died Mr Anthony Burbidge, of East Knoyle, Wilts, aged 81 years: he was a man of exemplary piety and universal charity, and his loss is much regretted by all who knew him. He has left a legacy of sixty pounds to the Salisbury Infirmary, besides various legacies to poor relations and others. He has bequeathed the interest of 100/. to be paid at Christmas (for ever) to 5 poor widows and widowers, and the sum of 20/. to the Sunday School at East Knoyle.
