1930 Tisbury Petty Sessions

Edward Lloyd, labourer, of Tuckingmill, and Walter Frederick Coombes, labourer, of 58 Church-street, Tisbury, were charged with being drunk in Tuckingmill-road on Christmas day. PC Daniels stated that at 2.45pm he found Coombes fast asleep on the roadside bank and Lloyd was unable to stand on his feet. Supt Barrett said the lads were seen afterwards and they admitted that they were overcome. He did not press the case and the magistrates discharged the defendants on payment of the costs.

William Thomas Francis (18), plumber's labourer, of West Tisbury, pleaded guilty to the theft of a shotgun, valued at 28s 6d, the property of Mr Gerald Wills, of Hatch House, on or about December 16th, also to stealing a pair of gumboots belonging to Frank Poole, groom at Hatch House, on December 14th. When arrested by PC O'Donnell on the charge of stealing the gun, the accused was wearing the stolen gumboots. He admitted both offences and said he was very sorry for what he had done. Superintendent Barrett said there was nothing known against the lad who was only 18 years of age. He was married on the day after he stole the gun, and was now out of employment. The Chairman said it was a serious matter but the magistrates did not want to send defendant to prison. He would be put under probation for two years and would be liable to be brought up for judgement if he failed to conduct himself properly.

Timber Merchant's Failure

The first meeting of the creditors of John Loveridge Lambert, of Polden House, West Tisbury, farmer and timber merchant, was held at the Official Receiver's office, Salisbury, on Friday, the official Receiver Mr H T Rowe presiding. According to debtor's statement of affairs, liabilities expected to rank for dividend amount to £2,067 13s 8d. Assets are estimated to produce £613 0s 2d, leaving a deficiency of £1,454 13s 6d. Debtor ascribes his failure to "paying excessive prices for timber and heavy losses on haulage". Mr S G Best, Avon Chambers, Salisbury, was appointed trustee of the estate with a committee of inspection, consisting of three of the principal creditors.

Recruiting Dance

A successful dance, organised by the officers and NCO's of A Squadron of the Tisbury and Hindon Troop of the Royal Wilts Yeomanry, took place at the Victoria Hall on Monday. In a speech during the interval, Colonel J Benett-Stanford, one time Colonel of the Regiment, appealed to the ladies present to use their influence to their utmost in an endeavour to get more young men to join the Troop. He said that it was the finest thing a man could do to service his country, and especially in such a distinguished Regiment as the Royal Wilts Yeomanry. The Regiment had seen service in Napoleon's time, and he hoped that more young men would come forward and join. Major C Lestock Read also appealed for recruits. Lieut J Morrison, as Troop Leader, and Sergt J Webster, also spoke.

Music for dancing was supplied by the band of the King's Dragoon Guards from Tidworth. The MC was Farrier Sergeant Gurd and also assisting in the arrangements were Squadron Sergeant Pickford, Sergeant Pike (Salisbury Troop) and Corporals Burton, Brain and Flower.

Rent Arrears

At Shaftesbury County Court on Wednesday, Colonel John Benett-Stanford, of Pythouse, Tisbury, Wilts, sought an order for possession of 78 Newtown, West Tisbury, occupied by Albert Buller, a carpenter. Mr W Farley Rutter said he had received a letter that morning containing money. The rent was £14 in arrears.

Mrs Celia Mary Bull, secretary to Colonel Benett-Stanford, said in answer to the Judge that defendant could pay 10s a month off the arrears but he had had chances before. His Honour: if he pays 10s per month in addition to the rent, will Colonel Benett-Stanford give him a chance? No. I am afraid not, because he wants the cottage for a man in his employ. An order for possession in 6 weeks was made and for £13 rent arrears.

A meeting of the Tisbury branch of the National Union of Agricultural Workers was held in the Oddfellows' Hall on Saturday to consider the farmers' proposals to reduce the minimum wage by 3s per week. The following resolution was unanimously passed: "That this branch deplures the motion before the Wilts County Agricultural Wages Committee to reduce the present minimum wage in the county as it feels that the present wage standard is too low and any reduction, however small, would make the farm labourer's already difficult task of making both ends meet, practically impossible.

Tisbury Petty Sessions

James W F Chalk, of Newtown, pleaded guilty to two larceny offences, the allegations being that he stole a mackintosh valued at £3, the property of R W Borley, and an overcoat belonging to F G Miller, at Tisbury, on November 11th. Mr Borley, of Shaftesbury, stated that he was shooting in Wardour Park on November 11th and left his mackintosh with others on the game cart. At the end of the day the mackintosh was missing and it could not be found.

PC Symonds stated that he saw the defendant in Church-street, Tisbury, on November 15th and told him that enquiries were being made concerning Mr Borley's coat missing from a game cart at Wardour. Chalk said "I picked it up in a field and intended to return it". Witness accompanied Chalk to his home and received from him the coat identified by Mr Borley, and another belonging to Frederick G Miller, labourer, of Ludwell, who was a beater at the shoot. Defendant also stated that he picked up the coat belonging to Miller. Miller stated that he left his coat on the game cart and discovered his loss when he was looking for Mr Borley's mackintosh.

There was nothing previously against the accused, who was stated to be out of employment. The chairman said it was a serious matter, but the magistrates did not want to send defendant to prison. Defendant was fined 10s on each charge.

1933 Tisbury Petty Sessions

Jane Coombs, 58, Hatch, West Tisbury, was charged with being drunk and incapable at Tisbury on January 13th. She pleaded not guilty. PC Symonds saw the defendant lying on the footpath in Station-road at 3.15pm. She had a bottle containing gin at her side and she was helplessly drunk. He hired a car and took her to her home at Hatch, but there was no-one to take charge of her, and he took her to the police-station for her own protection. When she was charged the same evening she said "I am very sorry". Her husband bailed her out.

Supt Barrett said the defendant was bound over in 1925 and 1929. The public-houses in Tisbury would not serve her at all. There was no conviction between 1925 and 1929 or since the latter date. Defendant was bound over for 12 months, and was ordered to pay the costs. A condition of the bond was that she was not to enter a public-house.

1934

Gipsy Fair

The Tisbury Women's branch of the British Legion held a Gipsy Fete and Fair in the grounds of Vale View, Tisbury, by permission of Mr and Mrs Berry, on Wednesday. The proceeds were for branch funds which are devoted to charitable purposes. Gipsy costumes, in which stallholders and many others were dressed, provided a novel effect. The stallholders were - Disabled men's goods, Miss Denniston, Miss Turner and Miss Burt; provisions and fancy goods, Mrs Lesley and Mrs Bellamy; gipsy stall, Mrs Coles and Mrs Ward; ice creams, Mrs Case; lemonade, Mrs Read. Teas were served by Mrs Jukes, Miss Highman and Mrs Bealing and the competitions were the charge of the local men's branch of the Legion.

In the evening there was an interesting entertainment. About 50 members and their children took part, all wearing gipsy costumes, and the setting was a realistic gipsy camp. The entertainment consisted chiefly of singing and dancing. Mr P Randall and Mr Charity gave vocal solos, Mrs P Randall accompanying at the piano. The fete and fair were arranged by the committee, Mrs Gornell chairman, Mrs F Burt vice-chairman and Mrs Turner hon. secretary.

She carried a bouquet of white chrysanthemums and was attended by four bridesmaids, the Misses Violet Hain (sister of the bride), who wore a floral two-piece georgette dress, Miss Cecily Shute, who wore a pale blue dress (both wore pink and blue crinoline hats), and the Misses Vera and Joan Martin, nieces of the bridegroom, who wore white silk floral dresses with white mob caps trimmed with asters and carried bouquets of asters. The best man was Mr W Tinham (brother of the bridegroom). The vicar, Canon A H Barnes, performed the ceremony and there was a large congregation present.

Letter to the Editor

"May I be permitted to express, through the columns of the Western Gazette, my utter disgust and disapproval of the rowdiness displayed by certain individuals who attend the football matches at Tisbury between the two local teams, i.e. Tisbury Town and Tisbury Hearts. These teams have played three matches this season. Each game has been keenly contested in a sporting manner by the members of both teams and good feeling evidently exists amongst the players. This cannot, however, be said of some of the Tisbury Town club supporters.

It is right and proper for supporters to encourage their respective teams whilst a game is in progress, but to hurl obscene, insulting, loud-voiced remarks at individual players is going too far. It is objectionable to decent minded persons who attend the matches and who love fair play all round.

The persons guilty of this bad behaviour do not appreciate the fact that the teams are doing their best to provide the public with a form of healthy recreation and pleasure, which is appreciated by the majority of onlookers. It is a pity the few should mar this enjoyment. As a supporter of the Tisbury football clubs, I trust this letter will be read by the guilty ones and taken to heart seriously, otherwise I and many others will withdraw support".

Tisbury Petty Sessions

Bessie Millward, of Tisbury, applied for a separation and maintenance order against her husband Josiah Millward, The Quarry, Tisbury, on the grounds of alleged desertion. Mr L Williams (Trethowan & Vincent, Salisbury) was for the wife and Mr A B Lemon represented the husband. Applicant gave evidence but after cross-examination by Mr Lemon, she accepted an offer of the husband to provide a home for her and her two children, and the Bench adjourned the case for a month. A provisional order was made to operate in the meantime and Mr A R White (who was acting as chairman) observed that the Bench hoped they would hear no more of the case and that the parties would settle down and live comfortably.

Storm Havoc

One of the most terrific thunderstorms experienced in Tisbury for many years occurred on Wednesday afternoon when the chimney stack of a dwelling house occupied by Miss L Lush was struck by lightning and partly demolished. The falling masonry caused a great deal of damage to the roof; a fireplace in the room was blown out, a window broken and articles dislodged for a shelf. A marrow growing in the garden was cut completely in half. The roof of the adjoining house, occupied by Nurse Foley, district nurse, was also damaged by the fall of bricks and the electric fuse box in the house was blown out. Hamlets only two miles south and west of the town were not touched by the storm.

1936 Storm and Floods - Postman's Problem

Acres of pasture land along the Nadder Valley were under water. Mr Arthur Marshall, a Tisbury postman, had great difficulty in completing his Christmas delivery. To deliver a parcel to Mrs Scott, who was imprisoned in her cottage at Savage's Bridge, he had to wade through water knee-deep and throw the parcel through an upstairs window. Water seven feet deep settled under Three Arches Bridge and neither vehicles nor pedestrians could get through, causing considerable inconvenience to both tradesmen and householders.

Game Prosecution Fails

At Tisbury Petty Sessions, Henry Herbert Green, of Totterdale Farm, Tisbury, was summoned for having trespassed in pursuit of game at Tisbury, and through his advocate, Mr A B Lemon, Salisbury, he pleaded not guilty.

Mr W Farley Rutter, for the prosecution, said Mr Arthur W S Aldridge rented the shooting of 5,000 acres on the Wardour Estate, which included a copse known as Wallmead Copse, adjoining Totterdale Farm, and Mr Cyril Williams and Mr Lever were employed by him as keepers.

At 3.30 pm. On October 24th, Mr Lever heard two shots fired. He went to Wallmead Copse and saw Green 10 yards inside the wood, who said someone had been shooting there and he had gone to the copse to see who it was.

After Green had left Lever found a dead pheasant, still warm, 12 yards from the spot where he and Green had been standing; a double-barrelled gun was found on the ground 10 yards from the pheasant. Green's employer had since reported to the police that he had missed his gun from Totterdale Farm.

Joseph Lever, the keeper, gave evidence, and, replying to Mr Lemon, he agreed that the pheasants were bred on the farm and were quite tame. Green could have got a pheasant, if he wanted one, without going far from his own door.

Cyril Williams, Swallowcliffe, head-keeper for Mr Aldridge, said he went to see Green and asked him what he was doing in the copse, and he replied that he thought he was doing everyone a good turn by going into the copse to see who was shooting.

Inspector Townsend said on November 21st Mr Hugh George Burt, the occupier of Totterdale Farm, who lived at Sutton Veney, reported the loss of a gun, the description of which fitted the gun brought to him by Williams. He interviewed Green on November 23rd, who said he did not hold a game licence and that he had not got a gun licence.

Hugh George Burt, of Sutton Veney, also gave evidence.

Mr Lemon submitted that there was no evidence against his client, who was perfectly cool throughout. His explanation was that he went into the wood to do Lever a good turn. There was no need for Green to steal the gun. The most they could say was that there was circumstantial evidence of a very flimsy character.

The Chairman said the Bench were of the opinion that the case had not been proved.

Lady Margaret Drummond Hay, of Dennis Farm House, West Tisbury, was summoned for having failed to comply with the lighting regulations. She was represented by Mr A B Lemon and pleaded guilty. Inspector Townsend said on two occasions since the offence, constables had reported infringements of the regulations, and private residents had also made complaints. P C Townsend gave particulars of the lights which were showing, and said when he rang the bell an outside light was switched on, which illuminated the outside of the house. He shouted for the light to be extinguished, and when he rang the bell a second time the outside light was again switched on. He saw the defendant the following morning, and she said she was away at a dinner party, but had given strict instructions for all lights to be screened. She had foreign servants. Mr Lemon expressed her ladyship's regret and said she had now taken steps to ensure no light could be seen. The Bench imposed a fine of £5.

The Bench then heard a summons against her ladyship for having failed to report the change of address of an alien and to this Mr Lemon pleaded not guilty. PC Townsend said he visited Dennis Farm House on September 8th to enquire for the registration certificates of all aliens living there. He did not receive a certificate for a Swiss alien and was informed that she had left. Later he saw Lady Margaret Drummond Hay, and she said she thought the girl had notified the police by 'phone, of her intention to leave the country. The bench imposed a fine of 20s.
